## A Message from the Exalted Ruler

We are proud to welcome two new members into our Lodge. They were initiated into the Order on Monday, January 24th.

Great news! Thanks to the generosity and diligence of our members along with our Elks National Foundation (E.N.F.) Chairperson, Nila Morrison, spearheading events that contribute to E.N.F., our Lodge has exceeded what the G.E.R. required. Each member is required to contribute \$4.80, but our Lodge has reached \$5,558 per member so far. Let's keep up the good work. On a statewide basis New Hampshire has contributed just over \$92,000 to E.N.F. since last April, an amazing accomplishment for such a small state.

Our Lodge applied for the Beacon Grant and the Spotlight Grant, and both applications were approved. By merging the two grants, the Lodge will be donating \$5,500 to the New Hampshire Food Bank very soon. The funds will be used specifically to help supply nutrition to remote areas in New Hampshire.

Thanks to all of the volunteers that helped make the Meat Raffle, Fish Fry, and the Sunday Breakfast a success last month. It was great to see a few "first timers" help out, and it was even better to hear that they enjoyed themselves and look forward to helping again. As always volunteers are needed. Please reach out to Lisa Saucedo if you are able and willing to volunteer for any of these events. New members are especially encouraged to volunteer.

There is a sign-up sheet on the cork board for volunteers to work a Wednesday night in the kitchen. Experience is not needed, but a willing spirit is. Without volunteers there is no food service. Talk to the Lodge Manager if you have any questions.

Nila Morrison, our Lodge E.N.F. Chairperson, is having a Mexican dinner on February 12th from 4 to 6 p.m. with proceeds benefiting E.N.F. Dinners will include two tacos and Spanish rice for \$8. You can choose whether you want chicken or beef and hard or soft shells. Advanced payment to a bartender on duty is required by the

February 9th deadline. On March 12th a St. Patrick's Day boiled dinner will be served with proceeds also benefiting E.N.F. Dinner will be \$10 per person and will include dinner and dessert. Again advanced payment will be necessary, and the deadline for this meal is March 9th.

Effective immediately the price per card for the Meat Raffles will be \$2. This is due to the increase in meat prices.

Nominations of officers for the 2022-2023 year will take place at the first Lodge meeting in February, and voting will take place at the second meeting of that month.
