January 4th is the date of the Lodge's reopening. After a few weeks of closure, a thorough deep cleaning of the Lodge was performed. Once it's open, all members will be required to adhere to the strict COVID health guidelines. The wearing of masks at all times, unless seated, will be mandatory. Socializing while standing will not be permitted. Wiping down all machines after each use will be required, and disinfected wipes will be available for our members to use. Please work hard to cooperate with and respect these guidelines, and please assist our bartenders and Lodge Manager in keeping the Lodge a healthy and safe place.

As you are all aware we had to postpone our Christmas Baskets Program due to COVID. So many of our members were ill, and it was not safe to proceed with the program in December. The new date for the baskets is Sunday, January 31st, at 8:00 a.m. Those members that had originally signed up to assemble the baskets will be needed to assemble, and those that had signed up to deliver will be asked to deliver. Due to COVID restrictions, no new volunteers can be accepted this time.

Due to disappointing attendance at the Wednesday night dinners, it has been decided that the kitchen will be closed on Wednesdays during the month of January. Hopefully the idea of "absence makes the heart grow fonder" will prove true, and members will support the kitchen once again in February and moving forward. With increased participation we will be able to include a wing night.

Please mark your calendars for January 15th for the Meat Raffle and January 22nd for the Fish Fry. Let's share some good times together with laughs and camaraderie, and let's support the Lodge and Elkdome.

In the month of February Grand Lodge will be mailing membership invoices to your homes. You will then have the option to pay your membership dues and make donations online, or you can choose to pay the Lodge Secretary with a check or cash. Hopefully this new option will make it easier for all of our members to take care of their financial responsibilities promptly whether they are near or far from the Lodge.

There is a matter of seriousness that needs to be discussed. In years past our members promptly and willingly stepped up to the plate and fulfilled their privilege and obligation to support

the per capita E.N.F. requirement, knowing that in order for the Lodge to receive grants to benefit the community, this goal needed to be met. The 2020-2021 rate set by the Grand Exalted Ruler was \$4.80 per member. Sadly our Lodge is about \$1,500 behind at the current time. In order for our membership to fully achieve the required goal by March 1st, we are requesting that each member make a contribution of \$5 or more. Generosity can be shown by either going to Elks.org and contributing, referencing Laconia Lodge 876; or members can make a check or cash payment referencing E.N.F. and leaving it with the Lodge Secretary. Thank you for your understanding and your commitment to being an Elk.

Winter is here, so snow will be falling. The Lodge Manager or bartenders may ask members to move their vehicles to a cleared area of the parking lot in order for a complete snow clearing. 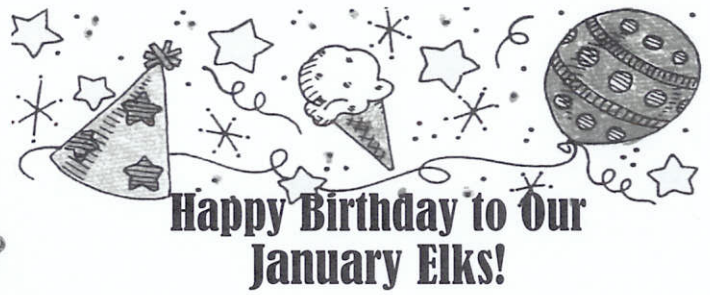

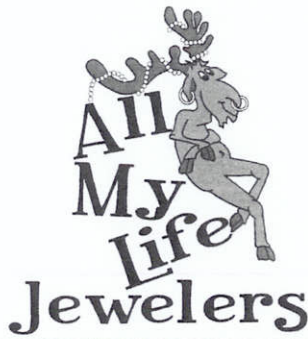
