# A Message from the Exalted Ruler

Exciting news!! The Lodge has been open for two weeks! Many members have been stopping by for a meeting, a bite to eat, a tasty beverage and socializing. For those of you who have been worried about safety concerns, please be advised that the Lodge Manager and Officers have implemented every health and safety precaution mandated by the Governor's Task Force. Masks are required for everyone while not seated. Tables are 6-feet apart with no more than six at a table. Bar stools are 6-feet apart. All lodge staff wear masks while working. Table service is being provided for food and beverage service. The goal of the Officers and Lodge Manager is to keep all of our members safe and healthy during these tenuous times.

Flag Day was amazing with a record attendance! A total of 80 people joined together to learn the history of, and honor our nation's flag and show true patriotism. In addition to our members, members of the American Legion participated along with Girl Scouts, Gilford firemen, the Gilford Police Department's Color Guard, Officer Wright who is a Belknap County Sheriff's candidate, and Retired Brigadier General, Donald Bolduc. A tremendous honor was bestowed upon the Lodge by Ret. Brigadier General Bolduc when he presented the U.S. flag that flew in combat in Kandahar, Afghanistan during Operation Medusa, a battle where the U.S., under his leadership, successfully defeated the Taliban. This flag was presented to the general by his men, and it will soon hang





proudly in our lodge.

Several members have said they are happy that the Wednesday night kitchen is open again and that other activities are opening up again now that the Lodge is open. Volunteers are needed if these events are to take place. There is a sign-up sheet on the cork board where you can volunteer for kitchen duties. If you prefer, call the Lodge and leave a message with the Lodge Manager stating which Wednesday you are free to work along with your phone number. Remember, no volunteers means no kitchen. As members we all share the responsibility to make the Lodge a successful, thriving, and pleasant place.

Please note the suggested bylaw changes for the Lodge. Listed are the current bylaws and the suggested changes. At August's lodge meeting voting on the suggested changes will take place.

In order for our lodge to thrive and prosper, membership needs to grow. As members we should be promoting Elkdom at every opportunity. There is no greater charitable, community minded, and patriotic organization in America. First, the dues were to be paid no later than April 1st for per capita expenses as per Grand Lodge. Secondly, despite the Lodge's temporary closure, financial obligations still had to be met for regular monthly expenses. This put an enormous strain on the Lodge. Please remember that you are an Elk, and you took a vow to honor your responsibilities. Stop by the Lodge to pay, or mail your check. If you want your membership card immediately, mail your check with a self-addressed stamped envelope. The Secretary will mail it to you. In addition to out-of-state members, some locals have chosen to receive the newsletter online at our Lodge's website, www.laconiaelks.org. This reduces overall expenses. 
